1 At the hearing on December 20, 2004, the Defense and the Prosecution reported to  
2 the Court that they would meet and confer regarding the discovery issues raised in the  
3 Defense Motion to Compel Discovery.

4 The parties have met and conferred. Many of the issues have been resolved. One  
5 issue that has not yet been resolved concerns the Prosecution's Bates numbering. The  
6 Prosecution has produced approximately 24,585 pages.

7 The Defense learned that it has a set of documents bearing Bates numbers that are  
8 different from those of the Prosecution's. It appears that the Prosecution produced  
9 documents to the Defense without keeping a copy. Alternatively, the Prosecution kept a  
10 copy, but numbered another set of documents differently.

11 The Defense attempted to resolve this numbering disarray, but was unsuccessful.  
12 The details will be explained in open court tomorrow.


