ARGUMENT

I.

IT IS PREMATURE FOR THE COURT TO RULE ON THIS EVIDENCE

The Court and defense counsel will have to hear the District Attorney's evidence. The prosecution has named certain experts but has not given the defense their statements. At this point, we anticipate that the prosecution will be contending that John Doe's behavior is consistent with being molested during the time periods alleged in the Indictment and that his preoccupation with sex related matters is a result of being molested. If so, we would intend to show that his preoccupation with sex pre-dated any allegations of molest in this case. At that time, we will comply with the Evidence Code in seeking to introduce that evidence.

For the above stated reasons, the Court should not rule on this evidence at this time.
