**NATURE OF PROCEEDINGS: OPPOSITION TO APPLICATION TO APPROVE ISSUANCE OF SUBPOENA DUCES TECUM TO POTENTIAL WITNESSES.**

Felony Complaint Filed December 18, 2003 charging the Defendant with Counts 1 thru 7: 288(a) P.C., a Felony, Counts 8 and 9: 222 P.C., a Felony, Enhancements on Counts 1 through 7: 1192.7(c)(6) P.C. and 1203.066(a)(8) P.C.

Indictment filed April 21, 2004 charging the Defendant with Count 1: 182 P.C., a Felony, Counts 2 through 5: 288(a) P.C., Felonies, Count 6: 664/288(a) P.C., a Felony, Counts 7 through 10: 222 P.C., Felonies, Special Allegations on Counts 2 through 5: 1192.7(c)(6) P.C. and 1203.066(a)(8) P.C.

**The Court made orders re: Application to Approve Issuance of Subpoena Duces Tecum to Potential Witnesses.**

At 10:05 A.M. with Court, Counsel and Research Attorney Jed Beebe present, hearing proceeded.

Counsel present for the People are Thomas W. Sneddon Jr., and Ronald Zonen.

Counsel present for the Defendant are Robert M. Sanger, and Susan Yu.

Counsel is present for potential witnesses.

A 977 Waiver is on file and the Defendant's presence is excused for this hearing.

The Court addressed the Opposition to the Application to Approve Issuance of Subpoena Duces Tecum filed by Attorney for potential witnesses.

The Court heard argument from Attorneys Sanger, Sneddon, and attorney for potential witnesses.

The Court granted the issuance of subpoenas as to potential witnesses and further granted the request of Attorney Sanger and endorsed the subpoenas for over 150 miles service.

Attorney for potential witnesses agreed to accept service of the subpoenas on their behalf via facsimile service.

The Court ordered Attorney Robert Sanger to prepare the subpoenas and include the endorsement for over 150 miles service.

The Court concluded the hearing on this issue.

Attorneys Sneddon and Sanger remain to address the Court regarding two issues involving the Special Master.

The first issue addressed is the previous request that Mr. Sanger provide a log for the documents on the seized computers. Mr. Sanger shall provide the Special Master Stan Roden with a Privilege Log of any documents of which a claim of privilege applies by Wednesday of next week. In addition, Attorney Sanger consented to the Special Master, Stan Roden reviewing confidential documents.

The second issue is the Search Word List that Attorney Sneddon previously provided. The Court requested Attorney Sneddon submit a condensed Search Word List that would narrow the results.

The Court further ordered that the transcript of these proceedings shall be sealed and a redacted copy shall be issued as requested.
