OBJECTION

Michael Joe Jackson ("Mr. Jackson") hereby objects to the admission of third party witnesses under Evidence Code Sections 1108 and 1101 regarding Mr. Jackson's alleged sexual offenses when the alleged victims will not be testifying.

Mr. Jackson suffered prejudice because he could not address 1108 or 1101 evidence in opening statement.

Such admission violates Mr. Jackson's constitutional rights to confront witnesses, to have a fair trial, to due process of law, to a fair and impartial jury, to the effective assistance of counsel, and to equal protection of the laws and the privileges and immunities guaranteed by the 4th, 5th, 6th and 14th Amendments to the United States Constitution and Article I of the California Constitution.


